








Wake County CoC is Under-Resourced Compared to Comparable CoCs




What Contributed to the Dramatic Difference in Awards Over Time?

- Assessed areas in which we have historically scored lower (e.g., performed lower than the national average)
- Assessed areas in which CoC-funded projects have disparities in performance
- Today begins our conversation about system and project performance—we are focusing on housing projects because of the upcoming NOFA; we will incorporate in other system components (outreach, shelter, coordinated access, etc in the near-future)


Households with Days Homeless Trend

















Time Distribution of Days Homeless


Average cumulative days homeless and distribution by defined time intervals for each household type.








Exits by Pathway









Returns to Homelessness Breakout Group Recommendations

- We see that almost all of the people who return to homelessness are those who went from Emergency Shelter to permanent housing without any housing intervention.
 - What target can we set for ourselves to improve over the next year for this population? (the 2019 NOFA expected a 5% reduction in the amount of people who exited to permanent destinations returning to homelessness).

Ideas from Other Communities

- Rapid Exit Case Management & Flexible Funding: some communities use housing-focused case managers and small amounts of financial assistance to help people develop plans to exit homelessness even if they're not going to be prioritized for a housing program like RRH or PSH. (Connecticut, SSVF providers, etc)
- Employment and Income Assistance: some communities have formal partnerships between coordinated entry and mainstream employment programs and disability employment and income programs in order to help people increase income even (especially?) if they're not going to be prioritized for a housing program.
- Targeting Homelessness Prevention: the only real known predictor of who will become literally homeless is if people have already experienced homelessness. For people who do exit without rental assistance (or even the 6% who returned to homelessness after RRH), could we target our homelessness prevention services to this group of people rather than a more scattershot eviction prevention approach?

What should we start thinking about to prevent people from returning to homelessness? (how will we reach people at-risk of returning to homelessness? targeting homelessness prevention rental assistance/supportive services, offering "rapid exit" services to people who are exiting independently, etc?)



Ideas from Other Communities

SSI/SSDI Application Assistance: dedicated SOAR workers (case managers whose entire job is completing SOAR applications) are more successful (90% success rate and 3 months average) than trying to build this expertise into a housing case manager's job. Funding legal service providers for appeals can also be helpful.

Partnerships with Employment Assistance Programs:
Formalizing partnerships and providing training and CQI relationsihps with mainstream and specialized employment programs can be successful. Building these questions into coordinated entry/housing plans and case conferencing can be helpful processes rather than leaving it up to individual housing providers to figure out. Employment First and supportive employment providers can be great partners.
