- Developing transparent processes, timelines, and tools for ranking projects eligible for funding under the CoC Program and other approved funding.
- Recommend rankings to the CoC Governance Board for a formal vote.

NC ESG Annual RFA Released


- Eligibility:
 - Applications are accepted from CoCs.
 - Non-profits or local governments
 - Agree to fully particpate in CoC CAS and adhere to CoC Written Standards
 - Data entry into CoC HMIS Sytem
 - Paticpation of at least 75% in CoC
 - Operate using Housing First, Low Barrier Housing model
- Fair Share / Available funding for NC 507
 - \$399,175
 - Emergency Response: \$239,505 (no more than)
 - Housing Stbilization: \$159,670 (no less than)

Intent to Apply Process

- For both New and Renewal Projects
- Eligible project types: RRH & PSH
 - Bonus project types may be included once NOFA drops
 - No Emergency Shelter or Transitional Housing Projects
- Due 2 weeks from the date the NOFA drops
- A Mandatory information session will be schedule with all applicants to review CoC timeline for application materials
