- Ensuring homelessness service providers receive ongoing training and learning opportunities.
- Recommend changes/modifications to the CAS Written Standards and the policies and procedures.

 Priority Category 1: Imminent risk of eviction w/ Documentation

Street Outreach

Priority Category 1: Matched to TH, RRH, or PSH

Emergency Shelter

Priority Category 1: Matched to TH, RRH, or PSH

Transitional Housing

- Priority Category 1: People not experiencing chronic homelessness
- Priority Category 3: highest VI-SPIDAT Score

Rapid Rehousing

- Priority Category 1: same as PSH when not available
- Priority Category 2: Highest RRH recommended score
- Priority Category 3: Chronic Homelessness
- Priority Category 4: Length of time homeless
- Priority Category 5: Overall Wellness (Domain D)

Permanent Supportive Housing

- Priority Category 1: Highest VI-SPIDAT Score
- Priority Category 2: Chronic Homelessness
- Priority Category 3: Length of time homeless
- Priority Category 4: Wellness (Domain D)

Current By-Name List Prioritization

- 1) Disability
- 2) Cumulative length of time homeless in a shelter or street outreach
- 3) Chronicity
- 4) Other programs client is enrolled in
- 5) VISPDAT
