What is the Annual Action Plan?

- Application to the U.S. Department of Housing and Urban Development (HUD) for annual entitlement funding
- Budget and framework for production goals
- Directly aligns with the City's and County's 5-year Consolidated Plan (ConPlan), which is an assessment of local housing and community development needs and outlines how federal funds will be used to address them
- FY 2024-2025 AAP is the final implementation of the current ConPlans

FY2023-2024 HUD Funding

CDBG: ~\$2.8 million

(Community Development Block Grant)

- Rehabilitation Programs
- Neighborhood/ Site Improvements
- Public Services

HOME: ~\$1.6 million (HOME Investment Partnership)

- Rehabilitation Programs
- Down Payment Assistance
- Gap Financing for Affordable Rental Development

ESG: ~\$255,809

(Emergency Solutions Grant)

- Rapid Re-Housing
- Homelessness Prevention
- Street Outreach
- Emergency Shelter Support
- HMIS Support

FY2023-2024 Local Funding

Local Funds: ~\$24.5 million (General Fund, Bond, Program Revenue)

- Rehabilitation Programs
- Down Payment Assistance
- Gap Financing for Affordable Rental Development
- Public/Private Partnerships

More Flexible Than HUD Funds

Increase the supply of affordable housing

- Programs include rental development, down payment assistance, and homeowner rehab and repair
 - Funded with Community Development Block Grant (CDBG), HOME, and local funds

Increase services to build selfsufficiency and sustainability

- Programs include public services such as the Community Enhancement Grant
- Funded with Community Development Block Grant (CDBG) dollars

Enhance the homeless to housing continuum

 \bullet

- Programs include rapid re-housing, homelessness prevention, emergency shelter, and other services to help those experiencing or at-risk of homelessness
- Funded with Emergency Solutions Grant (ESG) and Community Development Block Grant (CDBG) dollars

FY 2024-2025 AAP Timeline

Public Hearing #1 - Input December 5th, 2023 March 1st, 2024 **Draft Posted** 30-day comment period March 2024 April 2nd, 2024 Public Hearing #2 - Draft City Council adoption of the May 2024 AAP and submission to HUD

- Public meetings Mid-November
- Public survey November 1st through December 15th
- Two public hearings: December 5, 2023 and April 2, 2024
- 30-day public comment period: March 1 April 1, 2024
 - Draft Action Plan posted on City's website

 Priced out of the housing market

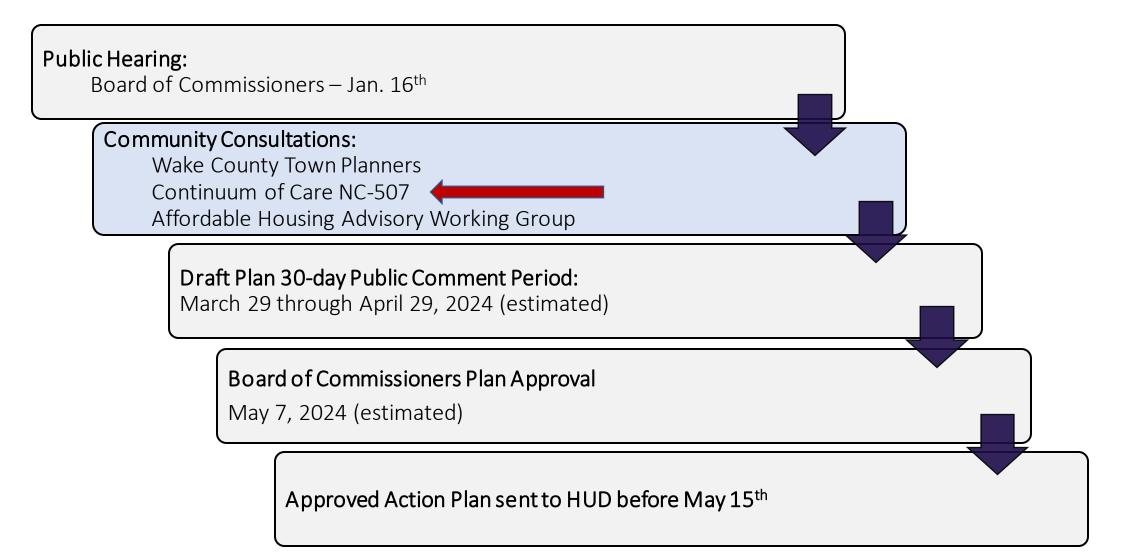

Sheltered people (including White Flag) will be counted through HMIS entry.



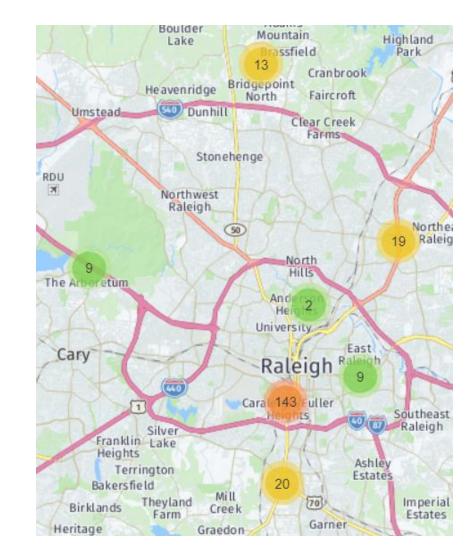
Unsheltered people are counted through the efforts of our Street Outreach professionals and our service sites.
