Eileen Rosa started the meeting by reviewing the agenda.

Wake CoC Updates

HMIS Updates

Thurston Alexander-Smith gave an update on the HMIS software request for proposals which was released on October 14, 2025, and will close on November 13, 2025. He stated that the scorecard is in development, and the scoring panels have been assembled.

Thurston Alexander-Smith covered other system updates including naming convention changes rolling out through the end of the year, as well as guidance on entering notes. Thurston also noted that the sharing agreements and release of information have passed legal review and will next require signature from each participating agency.

Coordinated Entry Updates

Katrina Wayne gave an update on the timeline for the Coordinated Entry system changes through the end of the year, including four (4) policies that will be voted on in November 2025:

- Victim Service Provider Policy and Form
- Inactive Policy
- Housing Vacancy Policy and Form
- Transfer Policy and Form

Katrina Wayne also shared that the VI-SPDAT and other SPDAT tools will be completely phased out by November 2025. Katrina shared that the VI-SPDAT has already been deprioritized and will be archived in HMIS.

- Point-In-Time Count
- Annual Committee Work Plans
