Under the Youth Homeless NOFO, the CoC's designated Collaborative Applicant or independent community must submit the selected and ranked project application(s). The Priority Listing affirms the CoC's or community's project application(s) selection.

You will answer "Yes" or "No" for each project application listed. For those where you select "Yes" you must also enter a unique rank number for each project. If you select "No" for a project application(s) you must select the reason you are rejecting.

If you need to amend a project application for any reason you **MUST** ensure the amended project is returned to the Project Listing **AND** complete the acceptance and ranking, or rejection process **BEFORE** submitting the Priority Listing to HUD.
